## Requirements of the Scholarship Program:

1. Must be a current, registered shareholder of Bay View, Inc.
3. Submit an essay outlining what your vocational educational goals are, and what you plan to do with your training once you have obtained it.
4. Participate in a completion survey upon finishing your training.
5. Provide a photo of yourself and sign a media release form.
